**PETITIONERS' OBJECTION TO THE  
 RECORD LODGED WITH THE  
 AGENCY**

IN THE MATTER OF APPLICATION FOR  
 PERMIT NO. 74-16187 IN THE NAME OF  
 KURT W. BIRD OR JANET E. BIRD

PETITIONERS, the Idaho Water Resource Board and the Idaho Department Fish and Game, by and through their attorneys of record, and pursuant to Rule 84(j)(1)(C) of the Idaho Rules of Civil Procedure and the *Notice of Lodging Agency Transcript and Record with the Agency* (July 21, 2020), hereby file this objection to the record lodged with the Idaho Department of Water Resources (“Department”), and request that the record be corrected, as discussed below.

1. The electronic record lodged with the Department includes three sub-directories, entitled “Agency Record PDF OCR,” “Hearing Exhibits,” and “Hearing Transcript.” The Petitioners object to the file in the “Hearing Exhibits” sub-directory entitled “Bird Exhibit 13.” This file should be “[l]imited to Figures 9 & 10 and Attachment B” of Exhibit 13 as originally offered by the Applicants, Agency Record at 01169,<sup>1</sup> but incorrectly includes the entire exhibit as offered.

During the hearing, the Petitioners objected to Exhibit 13 as offered by the Applicants with the exception of Figures 9, 10, and Attachment B, and the Hearing Officer limited admission of Exhibit 13 to Figures 9 and 10, and Attachment B. Tr., Vol. I, pp. 79–83; Agency Record at 01169. Figures 9, 10, and Attachment B are the 13<sup>th</sup>, 14<sup>th</sup>, and 15<sup>th</sup>–29<sup>th</sup> pages of “Bird Exhibit 13.”<sup>2</sup> The remaining portions of “Bird Exhibit 13” as lodged with the Department (*i.e.*, pdf pages 1–12 and 30–41) should not be included in “Bird Exhibit 13.” Petitioners therefore

request that the record as lodged with the Department be corrected so that "Bird Exhibit 13" consists of only Figures 9 and 10, and Attachment B.<sup>3</sup>

2. The "Agency Record PDF OCR" sub-directory includes copies of all protests to application 74-16187, with the exception of the protest filed by Lemhi Irrigation District on January 17, 2019. The Petitioners request that the record as lodged with the Department be corrected to include a copy of Lemhi Irrigation District's protest in the "Agency Record PDF OCR" sub-directory.<sup>4</sup>

3. In the "Agency Record PDF OCR" sub-directory, the file entitled "20200618\_Notice of Appeal and Petition for Judicial Review of Final Order Approving Application" was saved as a "...p" file rather than as a ".pdf" file, and cannot be opened unless it is re-saved as a ".pdf" file. Petitioners therefore request that the record as lodged with the Department be corrected to re-save the file entitled "20200618\_Notice of Appeal and Petition for Judicial Review of Final Order Approving Application" as a ".pdf" file.
