) **ORDER GRANTING**  
) **STIPULATED MOTION TO**  
) **SUSPEND APPEAL**

On March 16, 2023, Veolia Water Idaho, Inc. filed a *Petition for Judicial Review*. The *Petition* pertains to a transfer proceeding involving the *Partial Decree* entered in the Snake River Basin Adjudication for water right 63-9245. The Court subsequently filed a *Procedural Order* setting a hearing on the *Petition* for August 17, 2023, as well as various other deadlines. In addition, a status conference is currently set in this matter for July 6, 2023.

Then, on March 27, 2023, Veolia Water Idaho, Inc. filed a *Motion to Set Aside Final Unified Decree and to Correct or Amend the Partial Decree for Water Right No. 63-9245* in the Snake River Basin Adjudication. A status conference is currently set in this matter for July 6, 2023.

Both of these matters are currently pending before the Court and seek an order to modify the same condition included in the *Partial Decree* for water right 63-9245. On April 24, 2023,


the parties filed a *Stipulated Motion* to suspend the proceedings on the *Petition for Judicial Review*. The parties stipulate that it is judicially efficient and in the economic interest of the parties to suspend proceedings on the *Petition for Judicial Review* pending the Court's disposition on the *Motion to Set Aside Final Unified Decree and to Correct or Amend the Partial Decree for Water Right No. 63-9245* in the Snake River Basin Adjudication. The *Stipulated Motion* is unopposed. The Court in an exercise of its discretion, and for good cause shown, will grant the *Stipulated Motion*.

THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:

1. The *Stipulated Motion* is hereby granted.
2. Proceedings on the *Petition for Judicial Review* are hereby stayed pending the Court's disposition of the *Motion to Set Aside Final Unified Decree and to Correct or Amend the Partial Decree for Water Right No. 63-9245* filed in the Snake River Basin Adjudication.
3. All filing deadlines and hearings presently set in this proceeding are hereby vacated.
